### Aims and Outcomes

#### **Educational Aims of the Programme**

The overall aim of the programme is to produce postgraduates who are able to play a significant role in the development and implementation of policies, strategies and interventions in the field of Addiction. This will be achieved through the building of a sound knowledge base in both public health and addictions; and the key skills required to operate as a public health practitioner in this field. The specific aims are to: 1. Provide participants with the knowledge and skills to raise awareness of the population approach to health and bring an enhanced public health dimension to their work within their current or future employing organisation. 2. Provide a cutting edge curriculum which will enhance knowledge and understanding of key ideas and concerns in public health and addiction from an international, national and local perspective. 3. Develop/extend students capacity and capability to engage in partnership work with and for communities to improve health and reduce inequalities in health related to addiction. 4. Provide participants with a learning experience which will enhance their capacity and capability to develop new skills and knowledge as well as draw upon previous experience. 5. Prepare practitioners in public health related addictions to respond to and manage change in the workplace. 6. Provide opportunities for participants to develop leadership skills and methods of collaborative working. 7. Enhance career development opportunities for both students working within the field of addictions and those looking to enter a career in it.

# **Programme Structure**

#### **Programme Structure Description**

The awards of MSc and PG Cert Public Health (Addictions) are both offered as target awards. The awards of PG Cert and PG Dip Public Health (Addictions) are both offered as alternative exit awards. The MSc can be studied either part or full time. Students studying part time will be able to complete the MSc programme in 2 years. The pattern of study would normally comprise of: First year: 7000PUBHEA, 7010PUBHEA, 7019PUBHEA and 7011PUBHEA, plus 10 optional credits Second year: 7002PUBHEA, 7003PUBHEA, plus 10 optional credits Full time students will complete the MSc programme in one calendar year. The PG Cert programme can be completed in one standard academic year as a part time student. To qualify for the award of PG Cert Public Health (Addictions) (60 Credits) students must complete the following Core Modules: 7000PUBHEA, 7010PUBHEA and 7011PUBHEA. To qualify for the award of PG Dip Public Health (Addictions) (120 credits),students must complete the following Core Modules: 7000PUBHEA and 7002PUBHEA, 7010PUBHEA, 7010PUBHEA, 7010PUBHEA, 7010PUBHEA (Total 100 credits); plus 20 Optional credits. To qualify for the award of MSc Public Health (Addictions) (180 credits),students must complete the following Core Modules: 7000PUBHEA, 7011PUBHEA, 7002PUBHEA
