Educational Aims of the Programme

The aim of this programme is for students to gain academic and intellectual progression in discrete areas of international business, corporate and finance law, together with the acquisition of specific knowledge and skills. Programme Structure

Programme Structure Description

The Full Time course may be completed in 1 year (12 months); The programme permits a January start date. Base Structure: January entry

In Semester 1 (January to May), students will be enrolled on 60 credits: 7156LAWBC Advanced Legal Research plus two options. From June to September students will be enrolled on 60 credits 7157LAWBC Dissertation(may be commenced any time after completion of Advanced Legal Research Methods). In Semester 2(September to December) students will be enrolled on 60 credits which will consist of three options. These 3 options in the Semester 2 offering will include any modules that were validated after the students' enrolment in January, e.g. students who registered on the programme in January 2019 will be permitted to register on modules that were validated in May 2019, for delivery from September 2019.

Base Structure: September entry

In Semester 1(September to December), students will be enrolled on 60 credits: 7156LAWBC Advanced Legal Research plus options. In Semester 2(January to May) students will be enrolled on 60 credits which will consist of three options and from May to August students will be enrolled on 60 credits 7157LAWBC Dissertation.

The pass mark for all modules is 50% except for Advanced Legal Research Methods which is a pass/fail module. The rationale for this is that the module is a skills based module assessing basic competencies. This is normative within the discipline and has student body support. The Advanced Legal Research Methods Module must be passed prior to the submission of the Dissertation.

While all reasonable attempts will be made to offer all options in any given year, occasionally it may not be possible to offer a particular module. In such an event, students will be notified of this at the beginning of the course. An alternative exit award of Postgraduate Diploma in International Business Corporate and Finance Law will be offered to students who do not achieve a pass in the dissertation module but have gained 120 credits within the programme.

An alternative award of Postgraduate Certificate in International Business Corporate and Finance Law will be offered to students who have gained 60 credits at the point they exit the course, the 60 credits may not include the dissertation module.

Teaching, Learning and Assessment

The methods used to enable outcomes to be achieved and demonstrated are as follows:

All Learning Outcomes contained within this programme of study are assessed through the core and option Modules. Assessment is used to judge student performance against the standards set. Assessment is used to give students the opportunity to demonstrate achievement of the relevant learning outcomes in accordance with The QAA UK Quality Code Formative assessment is conducted through group interaction in the preparation of work for seminars, and summative assessment is provided through the completion of course work and the final dissertation. All taught modules, both Core and Option, are assessed summatively via written coursework of 4500 words. These assessments will require students to display independent learner status through exposition, knowledge and understanding of the stated Learning Outcomes for each Module and the programme as a whole.

Opportunities for work related learning

This programme of study is designed to enhance the employability and promotion prospects of persons in the international business corporate and finance sectors. It is relevant to a variety of individuals holding corporate and other positions within these discrete areas.

Additionally, this qualification develops skills appropriate to a range of careers within allied or related areas. Whether or not an individual pursues a career in business, corporate and financial law, this postgraduate degree will provide a set of intellectual and practical skills that will aid career development. Holders of this award may also find positions in the field of education and research including continuing their study for a Ph.D.
