#### **Course Structure**

The Full Time course may be completed in 1 year (12 months) and the Part Time course may be completed in 2 years (24 months).

The Modules studied for the LLM and MSc in this specialist field are identical in core and option. It is at the point of the Legal Research Methods and Dissertation modules that defines the LLM and MSc award. Students will be aware of the differences at point of application and enrolment and will make the decision of either LLM or MSc at this point. It should be noted that although the dissertation and research modules are listed as optional, they are in fact 'core'.

For the full time LLM, students will be enrolled on 180 credits which will consist of core modules 7124LAWPL, 7129LAWPL and 7135LAWPL plus four options.

For the full time MSc, students will be enrolled on 180 credits which will consist of core modules 7124LAWPL, 7130LAWPL and 7136LAWPL plus four options.

For the part time LLM, in Year 1 students will be enrolled on 60 credits which will consist of core modules 7124LAWPL and 7129LAWPL plus one option module and in Year 2 students will be enrolled on 120 credits which will consist of core module 7135LAWPL plus three option modules.

For the part time MSc, in Year 1 students will be enrolled on 60 credits which will consist of core modules 7124LAWPL and 7130LAWPL plus one option module and in Year 2 students will be enrolled on 120 credits which will consist of core module 7136LAWPL plus three option modules.

An alternative exit award of Postgraduate Diploma in Global Crime, Justice and Security will be offered to students who do not achieve a pass in the dissertation module but have gained 120 credits within the programme. An alternative exit award of Postgraduate Certificate in Global Crime, Justice and Security will be offered to students who have gained 60 credits at the point they exit the course, the 60 credits may not include the dissertation module.

#### **Teaching, Learning and Assessment**

Teaching, Learning and Assessment

The methods used to enable outcomes to be achieved and demonstrated are as follows: All Modules utilise blended learning through methods involving interactive, self-directed and independent learning. Lecturer-produced course documents, where appropriate, will be available on Canvas for students to access electronically. Students will have opportunities to collaborate with others in their learning cohort through either online forum and/or discussion. Technology supported learning plays a crucial role in the LLM/MSc. Generally, the teaching learning style of delivery is seminar/workshop based with students being required to undertake preliminary reading in order to prepare for and actively partake in group discussion. All taught modules, are assessed summatively via written coursework requiring students to display independent learner status through exposition, knowledge and understanding of the stated Learning Outcomes for each Module and the programme as a whole. The final Dissertation Module is assessed via an individual piece of coursework in a designated area of Global Crime Justice & Security negotiated with the Module Leader, supervising team and based on the initial foundations of research experienced in the Legal Research Methods Module.

This programme of study is designed to enhance the employability and promotion prospects of persons working in and with the international sectors. Other international requirements	Candidates whose entry qualifications were not assessed in English, must have attained a level of competence in English at least equivalent to IELTS score 6.0(with a minimum of 5.5 in each element) which should normally have been achieved within the last 3 years, failing which an additional English test may be required to be undertaken.
