Programme Structure

Programme Structure Description

The Full Time course may be completed in 1 year (12 months). The programme permits a January start date. Base Structure: January entry

In Semester 1 (January to May), students will be enrolled on : 7101LAWLM Advanced Legal Research Methods plus two options. In Semester 2(September to December)students will be enrolled on 60 credits which will consist of three options. Students will also be enrolled on the 60 credits 7100LAWLM Dissertation (year long).

Base Structure: September entry

In Semester 1(September to December), students will be enrolled on 60 credits which will consist of three options. In Semester 2(January to May) students will be enrolled: 7101LAWLM Advanced Legal Research Methods plus two options. Students will also be enrolled on 60 credits 7100LAWLM Dissertation (year long).

The pass mark for all modules is 50% except for Advanced Legal Research Methods which is a pass/fail module. The Advanced Legal Research Methods Module must be passed prior to the submission of the Dissertation. While all reasonable attempts will be made to offer all options in any given year, occasionally it may not be possible to offer a particular module. In such an event, students will be notified of this at the beginning of the course. An alternative exit award of Postgraduate Diploma in Law will be offered to students who do not achieve a pass in the dissertation module but have gained 120 credits within the programme.

An alternative award of Postgraduate Certificate in Law will be offered to students who have gained 60 credits at the point they exit the course, the 60 credits may not include the dissertation module.

All Learning Outcomes contained within this programme of study are assessed through the core and option modules.

Assessment is used to judge student performance against the standards set. Assessment is used to give students the opportunity to demonstrate achievement of the relevant learning outcomes in accordance with The QAA UK Quality Code. Formative through group interaction in the preparation of work for seminars, and summative through the completion of course works and final dissertation. All taught modules, both Core and Option, are assessed summatively via written coursework. These assessments will require students to display independent learner status through exposition, knowledge and understanding of the stated Learning Outcomes for each Module and the programme as a whole.

Opportunities for work related learning

This qualification develops skills appropriate to a range of careers within allied or related areas. This postgraduate degree will provide a set of intellectual and practical skills that will aid career development.
