Teaching, Learning and Assessment

Teaching and learning will take place through a combination of face to face lectures, small-group seminars, workshops, and one-to-one tutorials and focuses on theoretical and methodological material along with research methods. Directed and self-directed study will be delivered via the virtual learning platform (VLE) The assessment strategy depending on route taken includes (but is not limited to): Written essays 20,000-word dissertation Practice based competency assessments Written critical reflections OSCE (objective structured clinical examination) Written report Artefact written script Oral presentation Portfolio Poster Presentation

Opportunities for work related learning

The programme provides the basis for progression to PhD and a range of transferable research skills. The programme develops a range of transferable, work related, skills. Some students may also use their employment base for their fieldwork. Employers can also support employees by sponsoring bursaries - in this case students may conduct research on a work related area.

Alternative qualifications considered	Our philosophy enables us to accept a wide range of applicants. All candidates must be able to demonstrate the ability to benefit from and contribute to the programme. Each application is considered by at least two programme tutors, including the Programme Leader for MA Nursing Applications for MA Nursing will normally be considered in the light of ability to meet the following criteria: Generally, students must have completed an honours degree (normally 2:1 or above) in a related subject. Appropriate indicators will include two references, academic transcripts or their equivalent The student must demonstrate a sufficient level of knowledge to embark upon the programme (including the required linguistic competence) and to complete the programme within the required time limits. Students should provide evidence, in the view of the assessors, of the learning capability, study opportunity and commitment to a postgraduate programme of study. Any applications for recognition of prior (experiential) learning (RPEL) will be submitted to the EHC Faculty Recognition Group in line with the University's Recognition of Prior (Experiential) Learning Policy. The programme of study offers the candidate the opportunity to develop their personal and professional skills to an appropriate level Applications from non-standard applicants are welcomed. The Programme Leader will decide on whether to admit the candidate based on experience. Students who wish to undertake module 7100NPAPP during the programme must also be registered with either NMC as a Nurse (level 1)/Midwife/SCPHN, with a minimum of 1 years post registration experience in the clinical field in which they are intending to prescribe, OR with HCPC with three years relevant post-qualification experience in the clinical area in which they are intending to prescribe, and working at an advanced practitioner or equivalent level. Confirmation of satisfactory references and DBS checks are also required as well as completion of the NWNMPEG application form.
Other international requirements	Where English is not a first language, an IELTS score of 7 must be achieved. A minimum score of 7.0 is required within all components.
