#### **Course Structure**

Programme Structure Description

The program is designed based on modular structure in that students are required to successfully pass 240 credit points to earn a Higher Diploma award. In constructing the proposals, the course team has sought to ensure an appropriate balance between academic content and vocational skills. The programme seeks to provide students with the body of knowledge traditionally associated with International relations and to develop appropriate skills enabling students to apply such knowledge to different international contexts. The structure of year has been designed to provide a sound foundation in the field of study, and successive progression will allow them to learn advance contemporary issues in global relations. All modules are taught in English. The programme is offered as a two year full-time programme, with the students attending for 40 weeks per year. The programme is modular in design. The majority of modules are 15 credits.

### Teaching, Learning and Assessment

Teaching, Learning and Assessment

Learning Strategies The institution adopts student centred learning approach as they progress through the course. The course curriculum and assessment strategies are designed in a way that it supports the mission. The course will consists of cases drawn from the real world and addressing them in the class along with theoretical context of international relations. Active engagement with the subject material and class enhances learning and many of the learning strategies used attempt to promote this. Delivery of the curricular material will be through a blend of lectures, tutorials, group discussions, presentations, seminars and workshops. Assessments relate directly to learning outcomes and one assessment usually covers a range of such outcomes. In designing and deciding upon an assessment format for a module the following factors have been considered: • The module learning outcomes and their level, with particular emphasis on the student's ability to analyse, synthesise, evaluate and communicate information derived from: • Module content • Learned knowledge from other areas/qualifications • Experience • The implementation of systematic information-seeking strategies • Encouraging students to apply their skills to specific context • Approaching problems in a systematic way and employing test approaches that could resolve those problems • Assessment performance criteria, as communicated to the student • The validity and reliability of the assessment methods, which are monitored by module leaders, field groups and programme teams • Time constraints (for students and staff) and the need to ensure consistency • The use of a range of strategies through which a student can demonstrate what he or she knows, understands or can do • The need for assessment to allow for review and reflection by the student • The opportunity for formative assessment Assessments take the form of examinations (seen/unseen, open book, essays/short answers),essays, practical assessments, presentations, role-plays, individual and group reports, a dissertation or project. Increasingly assessment also takes the form of reflective blogs and wikis.

Alternative qualifications considered	Exceptional Entry Candidates who do not possess normal minimum entry qualifications are considered on an individual basis by members of the course team. Admission with Credit (Advanced Standing) Students with other qualifications wishing to enter the course may apply on the basis of RPL (Credit Transfer) for admission with Credit. Such claims must conform to College regulations for advanced standing and applicants must submit a portfolio of evidence. This will be assessed initially by members of the course team. The details required in this portfolio will depend upon the nature of the credit being claimed. The details on this is available with the student counsellor. Additionally the College accepts students with specific qualifications from approved Institutions abroad for entry onto the course. In such cases both the course content and the Institution will have been examined and approved by College staff. Such agreements are subject to change and review from time to time.
