Programme Structure

Programme Structure Description

The programme is delivered over 15 month and is taught within the University Academic Framework. There are two intakes per calendar year; in March and September. The programme is a closed client programme. Learners will be employed by the Probation Service with the BA (Hons) Community Justice forming one part of the Professional Qualification in Probation Practice (PQiP). Upon completion of the programme learners will not be able to practice as a Probation Officer unless they have completed and passed all parts of the PQiP. The programme has been jointly designed in conjunction with the Probation service, with content of the programme being externally dictated.

There are no taught modules at level 4 as all learners will apply for 120 credits Recognition of Prior (Experiential) Learning (RPEL) via LJMU Faculty Recognition Group. Some learners may be able to apply for credit transfer of level 5 credits (RP(E)L) depending on their prior qualifications and experience (see 'routes' below). All applications for RPEL and RPL will follow the process and procedures as outlined in the LJMU RPEL Policy. All Learners are required to complete all of the Level 6 modules and are unable to RP(E)L any prior learning or experience at this level.

Level 5 runs for six months and consists of four core modules (amounting to 80 credits) alongside two optional modules (each worth 40 credits). The four core modules are 20 credit modules (The Criminal Justice System; Understanding Crime and Criminal Behaviour; Penal Policy and Punishment & Rehabilitation) and these are each delivered over five weeks and sequentially to ensure development and to scaffold learning. There are two 40 credit modules (Adult learning and Reflective Practice & Professional Practice and Development). Each of these are optional and will run for the six months, enabling learners to assimilate and integrate learning from the 20 credit modules.

There are three 'routes' into the BA(Hons) for learners. These routes will determine the level 5 content to be completed by learners.

- 1. The Probation Service Officer pathway (PSOP) represents the route for those that have no previous degree and are currently employed by the Probation Service as a Probation Service Officer. Those who follow the PSOP route are required to complete all of the Level 5 core modules as well as the optional module: 5005COMJUS Adult learning and Reflective Practice.
- 2. The second route is for learners with a previous degree qualification in a non-cognate academic discipline. These learners will complete all of the 4 core modules and will be provided with the opportunity RP(E)L prior learning and experience to 5006COMJUS Professional Practice and Development via the gateway assessment Service (GAS) process.
- 3. The third route is for learners with a previous degree qualification in a partially-cognate degree disciple. These learners will only be required to complete one of the core modules, after applying for RP(E)L via the GAS process, applying prior learning and experience to the remaining three core modules and the optional module of 5006COMJUS Professional Practice and Development.

All modules at level 6 are core and learners are required to complete and pass all of the modules to gain the BA(Hons) Community Justice. Level 6 runs for nine months in total and there are five modules. There is one 20 credit module (Professional Ethics, Values and Practice) delivered over eight weeks and two 30 credit modules (Rehabilitation and Change Agency and Risk Assessment and Management) delivered over eleven weeks and two 20 credit modules (Developing Research Informed Practice in Criminal Justice and Developing Professional Practice in Criminal Justice) that are delivered over nine months with the intention of again allowing learners the opportunity to assimilate and integrate learning from the other taught modules. The 20 credit module (Developing Professional Practice in Criminal Justice) incorporates a submission of a career development plan as part of the

vocational qualification element of the Professional Qualification in Probation Practice (PQiP).

The alternative awards available are a Bachelor of Arts (BA) and the Diploma in Higher Education (DipHE). The BA will be awarded to those learners who achieve 300 credits (120 at Level 4, 180 at Levels 5 and 6, of which at least 60 must be at Level 6) as well as achieving the learning outcomes outlined in the overview section of this document. The DipHE will be awarded to those who achieve 240 credits: 120 at Level 4 and 120 at Level 5 as well as achieving the learning outcomes outlined in the overview section of this document.

Approved variance from Academic Framework Regulations

Variance

A variance to regulation UG A3.2 permitting a variation in module size has been approved to the following module: 5006COMJUS Professional Practice and Development.

A variance to regulation UG C8.1 (iii) has been approved. The award mark will be calculated using all 120 credits at level 5 and the 100 credits of mark bearing modules at level 6 (this excludes the pass/fail module (6005COMJUS) which must be passed but does not contribute to the award mark calculation) (Approved 10/1/23)

Teaching, Learning and Assessment

The programme has been designed in discussion with HMPPS and the Ministry of Justice and has been agreed as part of an external design approval board process. The programme is only open to PQiP learners recruited and employed by the Probation Service and the programme is one part of the overall PQiP Qualification.

The programme will be offered via an active blended learning approach and will consist of asynchronous (pre-recorded) and synchronous (live) and in person delivery methods and will use the full capability of the Canvas platform to engage the learners in the curriculum/modules that are delivered as part of the programme. This will include the use of pre-recorded materials, discussion boards, 'live' workshops/drop ins, quizzes, discussion boards and videos/podcasts. Learners will be encouraged to undertake independent study and this will form an essential part of the pedagogic ethos and promote independent learning. The teaching, learning and assessment activities will also embed opportunities for skill development seeking to support occupational vocational learning. These will particularly focus on communication, problem solving, collaboration, organisation and planning, cultural awareness, time management and interpersonal skills. These will be supported by self-reflection and the inclusion of the vocational element into a level 6 module. Each of the modules will have built into them formative processes that will contribute to overall academic development and to the associated summative assessments.

The programme team acknowledge that the profile of learners on the programme will be different to many undergraduate programmes that are delivered and as such each learner will receive a diagnostic assessment that will feed into an individualised learning plan. Learners will be supported through the programme in a variety of ways. Each of the modules will have a named module leader, learners will be allocated an academic tutor and they will additionally be allocated a PQiP personal tutor who will meet with them in accordance with the LJMU's Personal Tutor Policy. This is a bespoke role introduced as part of this programme to ensure the connections are made between the practice and academic elements of the programme and between theory, research and practice.

The assessment of intellectual skills is closely linked with subject knowledge and assessment skill, however there is a focus on learners being able to recognise, understand, assimilate and critically construct and defend arguments. All summative assessments will be to university standards and will include a variety of assessments methods including, online exams, presentations, case studies and essays. Overall 60% of the academic credits achieved will be done so through written work. This was agreed with HMPPS and The Ministry of Justice as part of the Design Approval Process as it is essential that competent probation practitioners possess the skills and ability to write a variety of reports and assessments and can evidence this as part of their academic engagement. All assessments will be structured around the learning outcomes set against each of the modules and the associated content.

All of the summative assessments will be submitted, marked (where appropriate) with feedback given via Canvas. Clear marking criteria and guidance will be provided to ensure clarity and support. As the learners progress through level 5 and 6 there will be opportunities for learning rubrics to be co-created. Feedback will be forward facing and developmental and will be provided in a variety of ways (audio, written and 1:1) to ensure engagement.

Opportunities for work related learning

As the learners on this programme are employed by the probation service, work related learning is integral to its delivery. Throughout the programme there are opportunities for the learners to relate their workplace practice to the academic elements and embed this in the various assessments linked to modules (case studies as an example).

Alternative qualifications considered	Candidates are recruited by the Probation Service and so application will become part of the Probation Service recruitment to the Professional Qualification in Probation Practice (PQiP), as outlined by the Ministry of Justice website. As part of the recruitment process LJMU will be consulted for advice and guidance on suitability to study at UG level and also to provide an assessment of equivalency of prior learning or experience.
